

REGULATIONS FOR ACCESS AND USE OF THE TEMPORARY CAMPING AREA

During the Mostra Scambio CRAME in Imola, a temporary, fenced-in camping area will be set up with limited space for tents, campers, caravans, and vans (sleeping in cars or vans not permanently equipped is not permitted). The campsite is equipped with both permanent and temporary restrooms and showers. Recycling of fresh water and wastewater is not permitted. **Access to and stay in the area is subject to compliance with the following rules:**

1) ACCESS

The area will be open on the following days and times:

Thursday, September 10th, from 2:00 p.m. to 7:00 p.m.

Friday, September 11th, from 10:00 a.m. to 1:00 p.m. and from 4:00 p.m. to 9:00 p.m.

The area must be vacated by **6 p.m. on Sunday, September 13th**. Access to the area must take place in accordance with the times specified in the booking form; late arrivals are permitted, but early entry is not (unless agreed upon due to specific requirements).

Daily rates applied:

- Tents up to 4 people €12.00 (maximum size allowed 2.50 x 3.00)
- Tents over 4 people €15.00
- Caravans - €22.00
- Campers up to 7 meters - €22.00
- Campers over 7 meters - €25.00
- Cars €10.00
- Motorcycles €8.00
- + €10.00 for each person (children: free up to 5 years; €5.00 for 6-12 year olds)

Electricity €10.00 (to be paid locally, if available)

Tourist tax €1.00 (exempt up to 14 years – to be paid locally)

Payment for your stay will be made in advance, except for "payable locally" items, via bank transfer, to be sent by email once the transaction has been completed.

In the event of cancellation by September 4th or for any event cancellations, the full amount paid will be refunded, excluding a €5.00 handling fee.

In case of failure to cancel or failure to access on the date indicated during the booking phase, the pitch will be made available again and only 50% of the fee paid will be refunded, less €5.00 for administration purposes.

2) AVAILABLE SPACES

The area has separate spaces for campers and tents. Cars and/or motorcycles belonging to tent crews will be parked in an area adjacent to the campsite (vehicles will not be parked near tents).

3) PERMANENCE

Campers and tents will be positioned according to the instructions provided by campsite staff. During your stay, **it is FORBIDDEN to light fires, use cooking equipment, or have barbecues**. Failure to comply with these instructions will result in **the crew being removed from the area**.

Space is guaranteed only as indicated on the booking form. For campers, only the side awning (awning) can be deployed, and **no additional tents and/or gazebos can be set up**. The same applies to tents; only the booked tent can be pitched, but no additional gazebos can be set up.

From midnight, in accordance with the municipal regulations in force in the Municipality of Imola, the silence hours come into effect: any noise that might disturb other guests and/or the neighborhood is prohibited.

4) RESPONSIBILITY

Please note that the area is not manned 24/7, so guests are asked not to leave valuables unattended. Management declines all responsibility for any thefts occurring on its pitches or from its vehicles.
